Respected Rashtrapati Ji,

I, Nittan Bhatia, S/o Late Shri Jagan Nath Bhatia, seek urgent intervention under Article 350 of the Constitution regarding unresolved grievances related to misuse of public money, perjury, and shielding of corrupt officials—issues repeatedly raised before authorities including the Supreme Court Registry, MoD, Cabinet Secretariat, and UP Govt, yet remain unaddressed despite RTI/judicial records.

Key Points:

1. **Misuse of public funds** to suppress RTI evidence (Contract No. GE No. 2/BLY/25 of 2000–01, Banbasa Road Repair, Bareilly Cantt).
2. **Promotion of Major Iqbal Aslam** to Colonel despite false affidavit (Dt 13.03.2003, Misc Case No. 33/2002).
3. **Inaction by MoD, Cab Sec & UP Govt** despite multiple refs to President. (PRSEC/E/2022/30970 via Jansunwai UP No. 60000220182661; revived & pending post PM Modi's resignation on 05/06/2024).
4. **Judicial inaction** despite verified documentary evidence under RTI from department itself, DOJ Letter No. L-15012/3/2013-Jus Dt 4th Oct 2013, L-15012/1/2014/Just-1 Dt 17.02.2014 and Email by pg-doj@gov.in to rg@allahabadhighcourt.in Dt 29.07.2019—violating redressal rights .



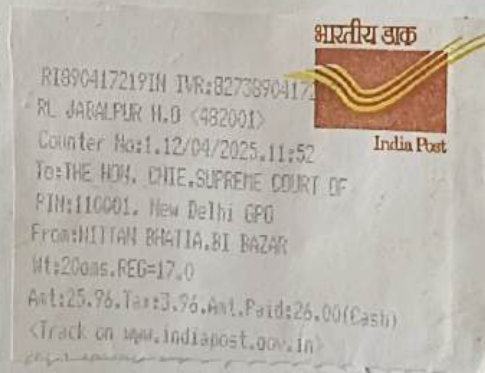
